MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter referred to as "Agreement") is executed on the 03rd day of July, 2015 at Kollam

BETWEEN

Fatima Mata National College (Autonomous), Kollam, registered under the minorities act, having its registered office at Near Railway Station, Kollam, Kerala – 691001, India, represented by Dr Saju S, Associate Professor in Physical Education (hereafter referred to as FIRST PARTY) which expression shall unless repugnant to the context or meaning thereof, mean and include its successors and permitted assigns of the ONE PART

AND

Radio Benziger, a community radio service having its registered office at Benziger Hospital compound, Beach road, Kollam represented by its Director Fr. Ferdinand Peter (hereinafter referred to as SECOND PARTY) which expression shall, unless repugnant to the context or meaning thereof, mean and include its successors and permitted assigns of the OTHER PART.

Whereas the First Party is a conventional Educational Institution and desires to equip the students with the latest broadcasting skills.

Whereas Radio Benziger is, inter alia engaged in the community broadcasting and is one of the leading FM service providers in Kerala. The company, with its corporate office at Kollam, has gained the reputation of being a provider of quality FM radio broadcasting. The objective is to empower the youth; mentor and assist them to upgrade their communication and broadcasting skills for improved employability, increased efficiency and career growth.

And whereas the First and Second Parties agree to enter into a broadcasting partnership under the following terms and conditions:

1. The Second Party will arrange to provide broadcasting and communication classes as well as training to equip the staff and students with the broad casting norms.
2. The Second Party will arrange broadcasting sessions
3. The duration of MoU will be for Five years commencing from the academic year 2015, until the end of the academic year 2020.

9. The Second Party would also fine tune the creative talents and help the participants have their skills catering to employability.
10. Training in developmental communication.
