#### MEMORANDUM OF UNDERSTANDING

- 2. Creating awareness to students on fishing, operation of fish hatcheries and fish farms, service activities incidental to fishing.
- 3. Coordinating coalition meetings, trainings and professional development workshops related to fish processing, package and export etc.
- Exchange of resources- Resource persons from the second party will conduct classes on areas related to fish culture and export.
- 5. Dr.Akhila Thomas will be the coordinator of the joint activities from partaker 1.

This MOU will commence on the date affixed by the signatories and will expire five years from the date of signing this document.
