Minutes of the Extra-Ordinary meeting of Anti-ragging Cell held on 16-6-2016.

Subject: The written complained given by Mary Carmel and her parents.

The complained was discussed thoroughly by the committee, and seeing that the complaint is genuine, the committee requested the principal to 'suspend' Martin M., Arun Varkey, Rahul Jith, Rahul George Thomas, and Bharath Rajan of II B Com with immediate effect pending enquiry.

Proceedings and Minutes of Anti-Ragging Committee held on 30-6-16. (2PM)

The anti-ragging committee conducted a serious enquiry about the complaint lodged by Ms. Mary Carmel of IBCOM (3rd sem) of this college.

A separate hearing was conducted for the alleged persons separately on 20-6-16.

A separate hearing was also arranged for 3 selected class mates of the alleged person (Aquila, Athulya and Athira) on 21-6-16 to collect evidences regarding the complaint.

The committee along with the Principle visited Commerce Dept. and interacted with the Faculty members to collect evidences on the complaint on 21-6-16.

The committee arranged a hearing for Mary Carmel and her parents separately on 25-6-16 (Saturday) as per their need.

The committee in addition to hearing, took signed written statements from the alleged persons, class mates and the petitioner. The committee also recorded the hearing details.

After a thorough analysis of the matter the committee reached the following conclusions.

1. Bharath Rajan, Rahul George Thomas and Arun Varkey George used the abuse language and the word 'fuck' against Mary Carmel during the first semester.
2. Arun Varkey George admitted that he and his friends used abuse language in the class-room.
3. Martin M. also gave written statement against these 3 persons regarding the use of abuse language.
4. The class mates of alleged persons and the petitioner, (Aquila, Athulya and Athira) informed that there was ~~no~~ ^{no} ~~any~~ unhealthy incident in the class happened during this semester. They recollected the incident in the first semester in which the HOD and Principal warned them and changed their seats in the class room.
5. Martin M. a former school mate of Mary Carmel was accused of calling her 'chalamery' and 'kolacka' even from her school days at St. Aloysius School and spread the nick name in the college. However, there was no evidence in this regard.
6. Rahul Jith was also accused of calling her nick name 'chalamery' and 'kolacka'. He also denied the charge and his colleagues never heard in this regard.
7. Her parents mentioned in their complaint regarding the message in the mobile phone.

of Athulya, II B Com, as the ~~reason~~ immediate reason for her suicidal attempt.

The faculty members of Commerce Dept. & Athulya and her class mates gave a satisfactory explanation in this regard.

Actually 'Chalamery' is the nick name of Athulya even from her school days. One of her school mate send a group photo to her mobile entitled "Chalamerians Sangavum". Athulya and her friends laughed at this photo in the quadrangle of the college.

Mary Carmel present aside made a misunderstanding that she was called 'Chalamery' by her ~~colleagues~~ class mates.

8. The petitioner failed to produce solid evidences or witnesses before the committee to substantiate her petition.

Under this circumstances, there is no evidence of ragging currently as by complaint raised by the petitioner.

9. How ever Mr. Bhanu, Bharath rajan, Rahul George and Arun Varday speak about words in English language even in the class room. They were irregular and late comers in the class. It was also noticed that they were reluctant to obey the advice of teachers. Some times they even mocked the teachers too.

Hence collect suitable undertaking and sufficient assurance from these students ~~in this regard~~ before allow them to enter the class.

10. The committee recommended the withdrawal of the suspension of the alleged students and may be reinstated to their class after giving counselling from an approved counselling centre.
