### REPORT SUBMITTED TO THE PRINCIPAL BY THE STUDENT GRIEVENCE REDDRESSAL CELL

Background: MSc semester 3 students of Department of Mathematics have registered a complaint to the Convenor, Student Grievence Reddressal Cell, dtd. 23.01.2019 regarding the scheduling of semester 3 and semester 1 post graduate examinations. Convenor reported the matter to the Principal, and held a discussion with Principal, Controller and Deputy Controller of Examinations. The Principal directed the Convenor to convene a meeting of the Cell on 24.01.2019 2.30 pm at Controller's office, and also directed the Convenor to summon the students who registered the complaint to appear before the meeting. The Controller and Deputy Controller of the examinations were also invited for the meeting.

Fifteen MSc (Mathematics) S3 students who lodged the complaint were also present.

The meeting started at 2.30 pm. At the initial phase of the meeting, the status of the complaint was discussed with the invitees. The complaint was regarding the scheduling of PG examinations, where those who opt for the supplementary chance for appearing the semester 1 examinations have to appear in continuous dates without any breaks, for semester 3 and semester 1 examinations. The students complained that this would make negative prospects in their examinations and they fear they would lose both the semester 1 and semester 3 examinations, if at least minimum breaks were not provided between the examinations. Controller of the examinations made a detailed statement regarding this, and he pointed out that the examinations were conducted in similar fashion during 2017 May. He said that the mixing of semester 1 and 3 examinations were happened in the background of the unprecedented sequence of events in the

campus, and it will not be repeated in the forthcoming examinations. He requested the students to go ahead with the current schedule, and otherwise their academic calender will be badly affected in the forthcoming semesters. Dr. Shaiju P.N., then made it clear that it seems quite unjustice to force the students for appearing the examinations on continuous dates, irrespective of whether it is regular or supplementary. This will make the students stressed and will make unnecessary mental pressure for the students. It will not make any prospects in their results, and pointed out that this kind of examination scheduling is one of the many reasons behind the current student unrest. He added that it is better to reschedule the examinations, if possible, to help the students at present. He also suggested that this type simultaneous examination schedules should be discouraged in future, for making the examination process student friendly. Dr. Sherley Williams, Dr. Sarau Devi and Mrs. Vimala, suggested it is better to go with already published examination schedule, and they expressed their concern in repeating this kind of complaints in future, if it is recheduled now. The students strongly requested to shift the entire s1 examination schedule, and suggested it has to start after completing the s3 examinations, as this is the normal examination schedule followed by University of Kerala. But the Controller and Deputy Controller expressed their helplessness in doing so, and they were firm on going with the present schedule.

Finally the students requested to shift the s3 examination posted on 7<sup>th</sup> February, 2019 to 11<sup>th</sup> February, and such a shift they said will make them a little bit comfortable. The committee members also supported this demand and requested the Controller to do so if he can. But the Controller said it is not practical since the other batches of students will then come with fresh complaints to change the examinations and this will make the examination process difficult to handle. Finally it is decided to submit a detailed report regarding this to the Principal and resolved that the Principal and Controller may take a decision in this case based on the report and other relevant documents and situations. This was reported to the students and the Controller himself agreed to make necessary arrangements to inform the final decision to the students, at the earliest. The meeting came to an end at 4.15 pm.
