

<u>ORDER</u>

As per the Government Order read above sanction was accorded to the District Collector, Thiruvananthapuram in charge of Kerala State Council for Child Welfare to print and sell 75 lakhs Flower Tokens (Children's Day Stamps) of ₹ 10 denomination each in connection with the Children's Day Celebrations 2013 for activities of the Council. In the letter read above Government have been requested to accord sanction to the Council to print and sell 80 lakhs Children's Day Stamps of ₹ 10 denomination each in connection with the Children's Day Celebration 2014 and for various activities of the Council.

(2). Government have examined the request in detail and are pleased to accord permission to the District Collector, Thiruvananthapuram in charge of Kerala State Council for Child Welfare, Thiruvananthapuram to print and sell 80 lakhs (Eighty Lakhs) Flower Tokens of \gtrless 10/- (Rupees Ten only) denomination each for the above purpose subject to the following conditions.

1. The Council should take immediate steps for collecting the outstanding amounts.

2. The monthly statement of accounts of Children's Day Stamps printed and sold during the year is to be submitted through the Director of Social Justice Department.

B. The number of Tokens to be printed shall not exceed 80 lakhs in any case.

4. The currency of Tokens will be upto 13.11.2015

5. The unsold and returned Tokens printed upto 2013 will be destroyed in the presence of Director of Social Justice Department.

- 6. The Tokens may be sold to the employees of Government Departments both Publi Private undertakings and Educational Institutions in the State. The State Council will all efforts to collect maximum amount and ensure that at least 70% of the sale pro of the Tokens are utilised for Child Welfare activities as provided by the Bye-law
- 7. The Council will submit a report to Government in Social Justice Department throug Director of Social Justice Department on the amount collected and utilised together audited statements of accounts not later than 31.3.2015.
- (3) All Heads of Departments and Offices, Corporations, Municipalities, Pancha Co-Operative Societies shall extend all support to the Kerala State Council for Welfare for distribution and sale of Flower Tokens.
