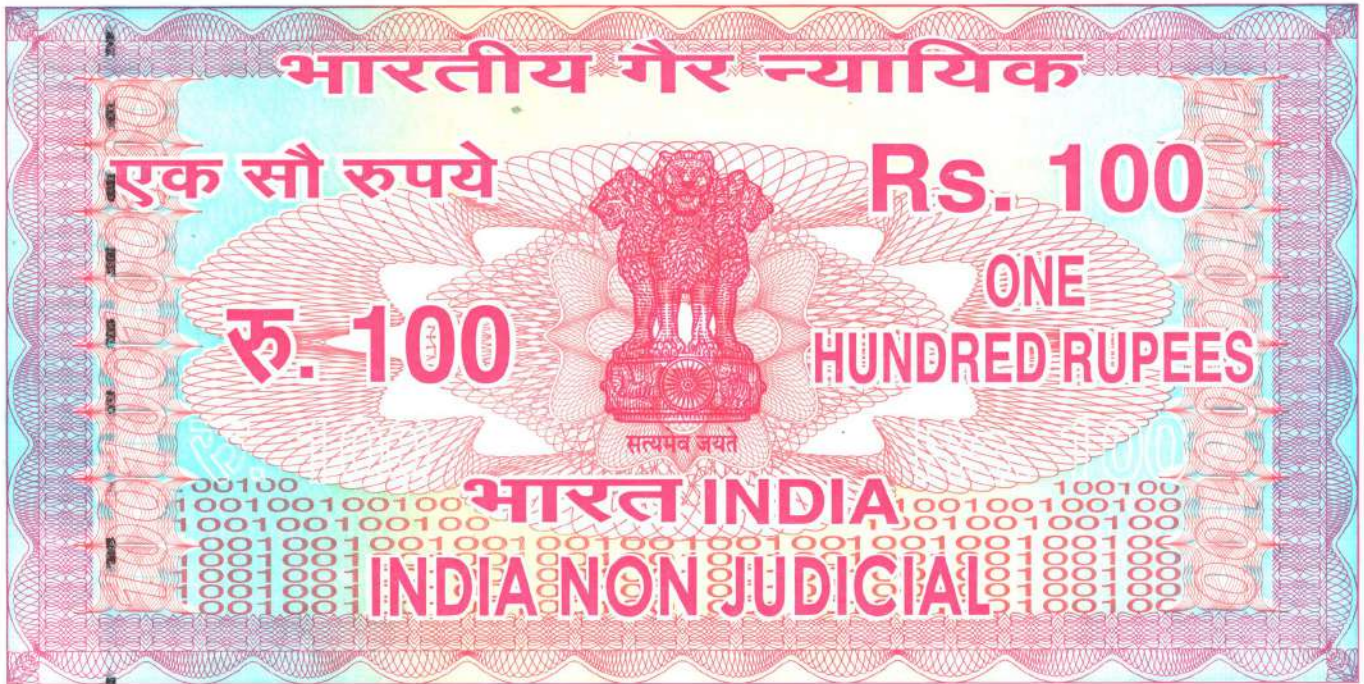

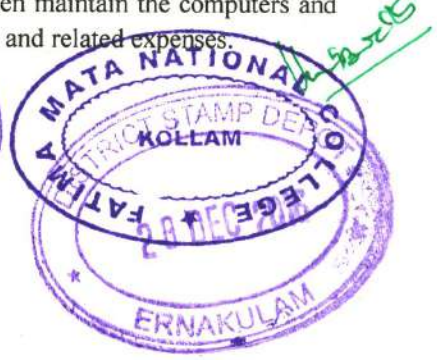

5. The Second Party will arrange qualified and competent Trainers to conduct the classes to the best satisfaction of the First Party. The dates and timings of these training sessions will be finalized on mutual discussion and can be changed on mutual agreement.

6. Dr. Vincent B. Netto will be in charge of the program as the representative of the First Party.

7. The course fee will be fixed at Rs.1000/- (Rupees One Thousand only) per lecture of one hour. This will be subject to revisions corresponding to any revisions of the UGC norms.

8. The second party will arrange industrial visits for the students. Conveyance and related expenses for the same has to be borne by the students.


9. There will be a joint evaluation of the programme conducted jointly by the First and Second Parties.


